The MTEF Mirage: Plans without commitment

Every year, we witness the same ritual unfold. Covered entities spend months crafting their Medium-Term Expenditure Framework (MTEF) — a meticulous four-year roadmap outlining how they intend to allocate resources to deliver better public services. The documents are impressive: bound reports filled with strategic objectives, detailed costings, and ambitious targets. The Minister for Finance presents them to Parliament. Development partners nod approvingly. Citizens hear the promises.

Then reality hits.

The MTEF was introduced as part of Ghana's public financial management reforms to bridge the gap between long-term development aspirations and annual budget realities. It was meant to inject predictability, strategic thinking, and results orientation into how we allocate public resources. Using a Programme Based Budgeting (PBB) approach, the MTEF estimates are intended to ensure continuity in service delivery across Ministries, Departments, and Agencies

(MDAs) as well as Metropolitan, Municipal, and District Assemblies (MMDAs). On paper, the concept is elegant: link national development plans to sector

strategies, translate those strategies into four-year budget frameworks, and use those frameworks to guide annual allocations. However, in practice, this has become more an exercise in wishful thinking than a reflection of serious commitments.

Take, for instance, the 2022–2025 Government of Ghana budget indicative ceilings and actual appropriations for the Audit Service, focusing particularly on goods and services and capital expenditure components (CAPEX).

The evidence is chilling: the indicative ceilings appear indicative of nothing. They do not meaningfully reflect either revenue forecasts or expenditure priorities. Instead, they often seem like arbitrary figures churned out to tick a box. From 2022 to 2025, there has been a consistent and wide gap between the indicative ceilings and the actual appropriations for each fiscal year, a pattern

evident in both goods and services and capital expenditure.


Two issues arise here.

First, one might argue that it is better when appropriations exceed indicative ceilings. That may be true, but this recurring trend defeats the very purpose of the MTEF as a rolling budget. It undermines predictability and renders the planning efforts of covered entities practically meaningless. The MTEF, which should serve as a credible forecast for future allocations, has become unreliable for guiding the planning of MDAs and MMDAs.

Second, while it is valid to say that indicative ceilings are merely estimates, estimates should not be arbitrary. Before these figures are produced, there should be a realistic forecast of both revenue and expenditure, aligned with national development priorities. Indicative ceilings ought to reflect current macroeconomic fundamentals, adjusted for expected conditions in subsequent years.

Audit Service records major gains in payroll cleansing and fiscal accountability - highlights from the 2026 Budget Statement

During the presentation of the 2026 Budget Statement to Parliament on 13th November, the Minister for Finance, Dr. Cassiel Ato Baah Forson, highlighted the important contributions of the Audit Service in safeguarding the public purse and strengthening fiscal integrity across government institutions.

According to the Minister, the Service continued to play a central role in promoting accountability throughout 2025. A total of 15 Auditor-General's Reports for the 2024 Financial Year were submitted to Parliament by the constitutional deadline of 30th June 2025, an achievement that reinforces the Service's commitment to transparency and timely reporting.

Dr. Forson noted that the Service completed 5,557 audits across Ministries, Departments and Agencies (MDAs); Metropolitan, Municipal and District Assemblies (MMDAs);



educational institutions; public boards; traditional councils; and donor-funded projects. This represents 79.83% of the annual audit target, reflecting improved operational efficiency and enhanced oversight systems.

A key highlight of the Minister's presentation was the Service's nationwide payroll audit, undertaken at the request of the Minister for Finance. The exercise, aimed at cleansing public payroll data and eliminating ghost names, uncovered GH¢150.36 million in

unearned salaries, allowances and other financial irregularities linked to 2,408 separated staff. Out of this amount, GH¢10.00 million has already been recovered and paid into the Consolidated Fund, with recovery efforts ongoing for the outstanding balance.

Through routine audits conducted nationwide, the Service also recovered GH¢14.95 million in additional unearned salaries and irregular payments. In total, GH¢13.00 million was transferred directly into the Consolidated Fund, reinforcing government's fiscal position and boosting public confidence in financial oversight mechanisms.

The Minister commended the Service for its "pivotal role in protecting the public purse," noting that the results achieved in 2025 demonstrate a stronger commitment to discipline, integrity and accountability across the public sector.

Beyond the needs of covered entities, multilateral development organisations, development finance institutions, and credit rating agencies rely on these indicative ceilings to make informed decisions. A wide deviation between indicative ceilings and actual appropriation sends a worrying signal about the country's credibility in its fiscal projections.

This issue is not just a technical glitch buried in spreadsheets and budget documents. The disconnect

between our Medium-Term Expenditure Framework and actual appropriations represents a crisis of credibility. When a district hospital director cannot rely on forecasts for future years; when a headmaster stops believing that the budgeted classroom with a three-year completion period can be executed based on indicative ceilings, and when citizens lose faith in government budget forecasts, we are confronting a deeper problem

that transcends the mechanics of public finance management.

Somewhere between the fiscal decision-making authorities who craft these frameworks, the covered entities that depend on them, and the communities where development should happen, something breaks down. The question that should concern every Ghanaian who cares about effective governance is simple, yet profound: Does our planning truly translate into results?

fill you up for fewer calories. When you sit down for your holiday meal, aim to make half of your plate vegetables (or fruits), a quarter lean protein, and a quarter whole grain.

Stop when satisfied

There's a Japanese phrase called "hara hachi bu", which means "eat until you're 80% full". It's essentially a reminder to stop eating when you're feeling satisfied (and before you're stuffed). It's easy to ignore fullness cues and continue eating when you're enjoying a yummy meal or if you're eating while distracted, but overdoing it can lead to digestive discomfort, weight gain, and leave you feeling sluggish. Using mindful eating strategies can help make it easier to stop eating before you're stuffed.

Get some sleep

Lack of sleep can inhibit the hormone leptin, which tells your body you're full, and increase the hunger hormone, ghrelin, causing you to feel hungrier. Getting sufficient sleep can help you regulate your hunger, keep you energized, and support your immune system. Try to limit screens at least an hour before bed, create a calm and soothing bedroom environment, and practice deep breathing to help you fall asleep.

Cheers to mocktails

More and more research is coming out revealing the negative effects of alcohol, but this time of year can come with a lot of peer pressure to enjoy a few drinks. If you're planning to drink alcohol, be sure to have a balanced meal beforehand and aim to have a glass of water in between each drink. Even better, opt for a fun and festive mocktail to enjoy holiday flavours without the negative impacts of alcohol.
